

BAB V

KESIMPULAN DAN SARAN

A. Kesimpulan

Berdasarkan hasil penelitian yang telah dilakukan mengenai analisis faktor-faktor yang mempengaruhi kepuasan wisatawan yang berkunjung ke Danau Weekuri, mengenai faktor aksesibilitas, amenitas, dan atraksi terhadap kepuasan pengunjung.

Dari hasil yang diperoleh, kesimpulan dari penelitian

1. Berdasarkan hasil uji F atau simultan, variabel aksesibilitas (X1), amenitas (X2), dan atraksi (X3) sebesar $119,951 > 2,70$, maka dapat disimpulkan bahwa semua variabel independen berpengaruh secara bersama-sama terhadap kepuasan wisatawan. Hal tersebut menyatakan bahwa h_1 diterima.
2. Berdasarkan hasil uji t didapatkan bahwa variable atraksi yang duga dominan berpengaruh terhadap kepuasan wisatawan memiliki nilai t hitung sebesar 11,138 dan nilai t table sebesar 1,985, maka nilai t hitung $>$ t table ($11,138 > 1,985$), sedangkan tingkat signifikan ($0,000 < 0,05$) yang artinya ada pengaruh antara variable atraksi dengan variable kepuasan wisatawan, maka h_2 di terima. Artinya variable atraksi berpengaruh secara dominan terhadap kepuasan wisatawan yang berkunjung ke Danau Weekuri.

3. Diketahui dari hasil penelitian bahwa besarnya angka koefisien determinasi (R^2) adalah 0,782 atau sama dengan 78,2% yang menunjukkan bahwa variabel aksesibilitas (X1), amenities (X2), dan atraksi (X3) berpengaruh terhadap variabel kepuasan wisatawan (Y) sebesar 78,2%. Sedangkan sisanya 21,8% dipengaruhi oleh faktor-faktor lainnya yang diluar variabel yang diteliti.

B. Saran

Berdasarkan pembahasan dan kesimpulan di atas, maka peneliti mempunyai saran untuk membantu meningkatkan kepuasan wisatawan yang berkunjung ke Danau Weekuri, sebagai berikut :

1. Bagi Pengelola Danau Weekuri
 - a. Pemerintah menyediakan sarana dan prasarana wisata yang belum tersedia dan menambah sarana dan prasarana yang ketersediaan atau kapasitasnya masih kurang.
 - b. Pengawasan dan perbaikan sarana dan prasarana penunjang bagi wisatawan, baik wisatawan local maupun wisatawan dari luar daerah dapat dievaluasi guna mendapatkan kepuasan wisatawan yang datang berkunjung ke danau Weekuri akan menikmati kawasan wisata alam ini.
 - c. Pengelola wisata danau weekuri harus meningkatkan citra destinasi yang ada serta terus melakukan promosi untuk memasarkan dan memperkenalkan danau weekuri melalui media sosial dan website yang memiliki jangkauan luas sehingga

informasi positif tentang wisata danau weekuri akan tersampaikan secara luas kepada calon wisatawan yang ingin berkunjung ke danau weekuri.

2. bagi Penulis Selanjutnya

Sesuai dengan harapan peneliti, penelitian ini dapat digunakan sebagai referensi penelitian selanjutnya, serta memperdalam penelitian yang akan datang. Dan dalam penelitian ini masih banyak aspek-aspek yang belum diteliti oleh penulis, sehingga penulis berikutnya diharapkan untuk meneruskan penelitian terkait tema yang penulis teliti.

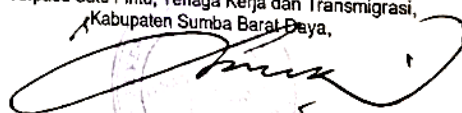
